# Submission requirements and information

## **Initial abstract**

- A 250-word abstract is required for submission which is used to determine the papers that will be selected for the conference technical and business program.
- The title should be concise and appropriately informative and should contain all keywords necessary to facilitate retrieval by modern searching techniques. Avoid using abbreviations in titles where possible.
- Abstracts may present information about equipment and tools but must show the definite applications and limitations of such equipment and should avoid commercialism and extensive use of trade names.
- Abstracts must be exclusive to the Australian Energy Producers Conference, and not one that has been presented or will be presented at another conference or published in another journal prior to the Australian Energy Producers 2025 Conference.

Previous presentations can serve as the basis of your paper; however all papers must incorporate new and original material.

- There is no limit to the number of submissions per speaker or authorship group but multiple submissions of the same material from different companies will not be considered.
- Proposals that are deemed to represent commercial advertising material (advertorials) will not be considered. To overcome this, we recommend publishing with an operator as a co-author.
- Confirmation of company and joint venture clearance must be obtained, or an outline of any concerns with the clearance of the final paper, together with a plan to obtain all approvals, must be provided.
- Please refer to the Call for Papers Step by Step Submission Guide.

#### No paper, no presentation

- Australian Energy Producers has a 'no paper, no presentation' policy. During the submission process you are required to indicate your preferred publication type (see Paper Types).
- Failure to submit a paper will result in the automatic removal of your presentation from the Conference Technical and Business Program.
- Your abstract should clearly outline the scope and content of the proposed paper.
- Shorthand and bullet point formats will not be accepted.

## Paper type and style guide

On submission of your abstract, you will be asked to specify your paper type (also known as publication style).

#### **Peer-Reviewed Papers**

- An academic paper
- Up to 5,000 words (main body)
- Maximum 15 figures/tables
- Maximum 8,000 total word count\* (main body, abstract, figure/table captions, references, author statements, author biography)
- Anonymised peer review by two reviewers
- To be published in the Australian Energy Producers Journal
- Submission due on 13 December 2024

\*word counts will be strictly implemented.

#### **Extended Abstracts**

- Non-academic paper
- Up to 1,500 words
- Up to three figures/tables
- Maximum 2,300 total word count\* (main body, abstract, figure/ table captions, references, author statements, author biography)
- Technical Program Committee to review
- To be published in Supplement 1 of the Australian Energy Producers Journal
- Submission due on 31 January 2025

## **Presentation types**

There are two presentation types for the Technical and Business Program.

### Oral

- Visual (poster)
- To be presented live within an oral session
- Duration of the oral presentation is 14–18 minutes
- Question time within the session

## To be on display in the Visual

- Presentation Area, within the Exhibition for the duration of the Australian Energy Producers 2025 Conference & Exhibition
- Either printed or digital presentation format is available (authors' choice, digital attracts a fee)
- Dedicated 'Meet the Authors' session within the program (Day 2)

You will be asked to provide your preferred presentation type upon submission.

## Authorship details

Within the submission process the below is required for each author:\*

#### Title

First name and initial, if applicable Surname Position/job title All represented institution/company details, including the full name and address with city, state and country for each institution. \*See 'Speaker responsibilities and requirements' on page 7.

## Speaker responsibilities and requirements

- The nominated speaker must be a registered full, day or student delegate, with nil funds owing, and attend the Australian Energy Producers 2025 Conference & Exhibition in Brisbane. A 20% discount is provided to one speaker per presentation.\*
- The speaker will present the final submission in person during the Technical and Business Program at the Australian Energy Producers 2025 Conference & Exhibition.
- A 150-word biography in a Word document format is required upon submission.
- A high-resolution headshot photo in JPEG format (300dpi) is required upon submission.
- If the original nominated speaker is unable to attend the conference, a co-author can present. Registration requirements as listed above still apply.
- A maximum of two speakers is allowed per presentation, regardless of presentation type. One speaker to be nominated in an on-stage panel Q&A scenario.
- We strongly recommend the speaker is the corresponding/ lead author for the submission.

## Authorisation

Upon acceptance, the speaker and authors will be required to provide authorisation to Australian Energy Producers for:

- Licence to publish this includes the applicable paper and presentation to be published in the Australian Energy Producers Journal (2025).
- Clearance from presenting companies and joint ventures.
- Your abstract, photo/headshot, biography and other material to be used by Australian Energy Producers for marketing prior to, during and after the conference.
- The speaker's details including full name, position, company, email and phone number to be provided to their fellow session speakers and session chairperson.

## Australian Energy Producers Journal

Presentation material from the Australian Energy Producers Conference is published in the Australian Energy Producers Journal.

The Australian Energy Producers Journal (2025) and Supplement 1, containing all Peer-reviewed Papers and Extended Abstracts will be published on Friday 23 May 2025.

Supplements 2 and 3, containing all Technical and Business Program presentation material and the Plenary Session and Panel Series recordings will be published on Friday 20 June 2025, three weeks post event.

#### **Please note**

- To ensure all presentation material is included in relevant conference publications, including the Australian Energy Producers Journal prior to the conference, authors who do not meet the listed key dates will be removed from the Conference Technical and Business Program and the Australian Energy Producers Journal and/or supplements.
- If accepted, the decision on the presentation type and program allocation will be determined by the Technical Program Committee.

## **Review process**

### All submissions will be evaluated and scored in accordance with the following criteria:

- Does it contain new/original knowledge or experience in a field of relevance?
- Is the data in the paper proposal technically correct?
- How relevant is the material to the upstream energy industry?
- How well is the submission written?
- How well is the message conveyed?
- What is the overall effectiveness of the submission in conveying its message?

#### **Please note**

- The Technical Program Committee will review all submissions.
- Submissions discussing case studies are highly regarded.
- Submissions cowritten by operators and consultants help in overcoming advertorials.
- If accepted, the decision on the presentation type and program allocation will be determined by the Technical Program Committee.
- The final program will be created by the Australian Energy Producers and the Technical Program Committee.
- Abstracts might meet the quality criteria for the program, but they
  may not be accepted if there are insufficient papers on that theme or
  topic. The Technical Papers Committee will select papers that ensure
  the best overall program for the conference.
